Aloha Employees, Residents, Families and Friends:

On 09/23/2022, CMS released revised guidelines in response to the COVID-19 Public Health Emergency related to Long-term Care (LTC) Facility Testing Requirements and Nursing Home Visitation – COVID-19. In light of the revised guidelines and recommendations, Aloha Nursing Rehab Centre has imposed the following updates...

## Visitors

- Visitors will be screened and observed for signs and symptoms of COVID-19 prior to visitation. If you are sick, have had close contact or have tested positive for COVID-19, refrain from in person visitation. COVID-19 positive visitors should self-isolate for 10 days based on CDC Criteria for Health Care Settings.
- Visitors will wear a facial covering/mask at all times during the visit (nose and mouth covered).
- Visitors will perform hand hygiene and adhere to social distancing (6-foot distance) when possible.
- See Guidelines for Visitation, Effective September 28, 2022, for additional guidelines.

## Residents

- Residents are encouraged to wear a facial covering/mask (nose and mouth covered) when out of their room, perform hand hygiene and social distance when possible.
- Communal activities, dining and outings will be resumed.
- Newly admitted residents will wear a facial covering/mask (nose and mouth covered) when out of their room for the first 10 days following admission. COVID-19 testing for newly admitted residents will be performed on Days 1, 3 and 5.
- There will be no routine testing for COVID-19, but testing will be conducted upon symptom onset (Day1) or identification of positive COVID-19 high risk exposure (Day 0), on Days 1, 3 and 5.
- If COVID-19 positive, residents will be placed on isolation or transmission based precautions for 10 days. During an outbreak (facility acquired resident or staff positivity), COVID-19 testing will be performed using a contact tracing-based testing strategy for residents and staff with periodic testing until there have been 14 days with no newly identified positives.

## Staff

- All staff will be screened and observed for signs and symptoms of COVID-19 prior to their shift. If you are sick, notify your supervisor prior to reporting to your shift.
- All staff will wear a facial covering/mask (nose and mouth covered) at all times while in the facility and in patient care areas.
- There will be no routine testing for COVID-19 but testing will be conducted upon symptom onset (Day1) or identification of positive COVID-19 high risk exposure (Day 0), on Days 1, 3 and 5.
- If COVID-19 positive, staff will self-isolate based on degree of signs, symptoms and staffing criteria as determined by the Infection Preventionist and/or Director of Nursing.
- All staff are required to wear a face shield while in a resident room during an aerosolized procedure.
- When caring for a COVID-19 positive resident an N95, face shield, gown and gloves are required.
